## About Us

The **Northeast Chapter** of the Combined Heat and Power Alliance advocates for the deployment of highly efficient CHP systems throughout the Northeast and supports policies that recognize CHP's reliability, climate, and economic benefits. Members include manufacturers, system developers, engineering firms, end-users, and others. Our work spans eight states: Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, and Vermont.

The Northeast Chapter's activities include:

- Engaging in regulatory comment periods, rate cases, stakeholder forums, and other policy discussions where CHP is implicated.
- Meeting directly with state and local leaders to discuss the benefits of CHP.
- Hosting an in-person conference and multiple virtual events that bring together key voices in the CHP community and keep our members informed.

This work would not be possible without member support! Members also help to shape our policy positions, share vital information on quickly-evolving policy landscapes, and widen our reach.

## Our History

In 2023, the Combined Heat and Power Alliance (CHPA) merged with the Northeast Clean Heat and Power Initiative (NECHPI) to form the Northeast Chapter of CHPA.

The merger allows CHPA and its new chapter to streamline their advocacy efforts and maximize influence. Prior to becoming part of CHPA, NECHPI had a 20-year history engaging in energy policy across the region.

## Advocacy Highlights

Recent activities include:

- Submitting comments urging CHP's inclusion in Massachusetts' Alternative Portfolio Standard and Clean Heat Standard.
- Engaging directly with New York City officials and participating in a working group to shape implementation of the building efficiency law, LL97.
- Promoting CHP in Connecticut's Comprehensive Energy Strategy, Rhode Island's Renewable Energy Standard, and New York's proceedings on its Clean Energy Fund.

## Why should my company join the NE Chapter?

Through our advocacy before state public utility commissions and independent system operators across the Northeast, members benefit from decisions that reflect the expert input CHPA can provide.
